## Resolution of the Board to Set Tax Rate

Date: August 18, 2025

On this date, we, the Board of Trustees of the Wink-Loving Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2025 at a total tax rate of \$0.7942 be assessed and collected by the duly specified assessor and collector as follows:

\$0.6689 for the purpose of maintenance and operations, and  
\$0.1253 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

Adopted this 18<sup>th</sup> (date) day of August, 2025, by the Board of Trustees.

ORDINANCE NO. 1333

AN ORDINANCE OF THE CITY OF MONAHANS, TEXAS, LEVYING TAXES FOR THE 2025 TAX YEAR FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF MONAHANS, TEXAS, FISCAL YEAR BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026

WHEREAS, a no-new revenue tax rate was calculated by the Ward County Tax Assessor Collector and published in accordance with Chapter 26 of the Texas Property Tax Code.

*NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONAHANS, TEXAS:*

**SECTION 1.** That there is hereby levied for the 2025 Tax Year upon all property, real and mixed, not exempt from taxation by the Constitution and Laws of this State, situated within the corporate limits of said City for the use and support of the Municipal Government of said City of Monahans, and to provide for Permanent Improvements of said City, a Tax of thirty-three thousand, four hundred forty-one hundred-thousandths of a cent (\$0.33441) on each One-Hundred Dollars (\$100.00) of valuation of property as aforesaid; and said tax, so levied and collected, shall be apportioned to the specified purposes hereinafter set forth, to wit: For payment of current expenses and to be deposited in the General Fund, thirty-three thousand, four hundred forty-one hundred-thousandths of a cent (\$0.33441) on each One-Hundred Dollars (\$100.00) of valuation of such property.

**SECTION 2.** This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy.

**SECTION 3.** THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

**SECTION 4.** THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.23 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-15.59.

**SECTION 5.** The effective date of this ordinance shall be October 1, 2025.




